

**AMENDMENT NO. 1
TO AGREEMENT FOR PROFESSIONAL SERVICES WITH CAROLLO ENGINEERS, INC.
FOR A GROUNDWATER RECHARGE EVALUATION
FOR LAGUNA COUNTY SANITATION DISTRICT**

THIS AMENDMENT, effective as of the date last written below, is entered into between the Santa Barbara County Water Agency, a dependent special district of the County of Santa Barbara, a political subdivision of the state (hereinafter COUNTY) and Carollo Engineers, Inc., having its place of business at 3150 Bristol Street, Suite 500, Costa Mesa, California, 92626 (hereinafter ENGINEER).

WHEREAS, the parties hereto, on September 13, 2022, entered into an agreement (BC22-140) for performance of professional services by ENGINEER in connection with the Laguna County Sanitation District Indirect Potable Reuse Evaluation (the "Original Agreement"); and

WHEREAS, the Original Agreement term is through June 30, 2023; and

WHEREAS, it is necessary and appropriate to extend the term of the Original Agreement in order for ENGINEER to complete the work.

NOW THEREFORE, the parties hereto agree as follows:

- A. Paragraph 4, "Term" of the Agreement is hereby extended to December 31, 2023.
- B. Except as expressly amended herein, the Original Agreement shall remain in full force and effect.
