*WHEREAS, Loli has been a dedicated public servant, mentor to many across the department, generously investing her time and knowledge to foster employee growth, provide great customer service to clients and peers alike since the beginning of her journey. Her CalWIN and departmental knowledge, honored friendship and remarkable sense of humor, has left many wishing she would stay on forever; and*

*WHEREAS, Loli is now joyfully entering a time in her life where she can enjoy the continued success of her beloved children, Kate, Jill and Daniel and husband Dave, enjoying special times and building everlasting memories, as she cruises off in her retirement dream car listening to musical greats.*
