WHEREAS, California Vehicle Code Section 22507 and the Code of Santa Barbara County, California, Section 23-11, authorize the Board of Supervisors of the County by Resolution, to restrict the stopping, parking, or standing of vehicles, and designate parking restrictions on portions of roads and highways under its jurisdiction;

WHEREAS, it is in the best interest of public safety that certain portions of County streets or highways in Santa Barbara County be designated with parking restrictions in accordance with said Sections; and

WHEREAS, the parking restrictions imposed by this Resolution shall not be enforceable until signs or markings giving adequate notice thereof have been placed.

NOW THEREFORE, IT IS HEREBY RESOLVED AND ORDERED that the following locations in Santa Barbara County and under the jurisdiction of the Board of Supervisors of said County are hereby designated as:

No Stopping, Standing or Parking Zones

- On the east side of Eucalyptus Hill Road from a point 115' north of the centerline of El Rancho Road to a point 200' south of the centerline of El Rancho Road.
- On the south side of Pardall Road from a point 81 feet west of the centerline of Embarcadero Del Norte to a point 145 feet west of the centerline of Embarcadero Del Norte.
- On the east side of Camino Del Sur from a point 220 feet north of the centerline of Sueno Road to a point 291 feet north of the centerline of Sueno Road.
- On the north and south sides of Apollo Way from the centerline of Constellation to its eastern terminus.
- On the east side of Norris Street from a point 65 feet north of the centerline of Pinal Avenue to a point 155 feet north of Pinal Avenue.
- On the east side of Norris Street from a point 220 feet north of the centerline of Union Avenue to a point 325 feet north of Union Avenue.

Loading Zone

• On the south side of Pardall Road from a point 148 feet east of the centerline of Embarcadero Del Mar to a point 176 feet east of the centerline of Embarcadero Del Mar.

15 Minute Time Limit Parking Zone (9:00am to 6:00pm excluding Sundays and Holidays)

• On the east side of Embarcadero Del Norte from a point 67 feet south of the centerline of Pardall Road to a point 117 feet south of the centerline of Pardall Road

IT IS FURTHER RESOLVED, that the Santa Barbara County Director of Public Works or designee is hereby authorized and directed to designate said locations with appropriate markings and/or signs as time and resources permit.
