On Tuesday October 3, 2023 the Board of Supervisors will hold a public hearing to consider the appeal of the Planning Commission's August 9, 2023 approval of the revision to 16CUP-00000-00031 Condition No. 38 concerning the timing for golden eagle take authorization from the U.S. Fish and Wildlife Service (USFWS) for the Strauss Wind Energy Project.

On August 9, 2023, the Planning Commission approved by a vote of 3 to 2, a permit revision to require that Strauss Wind Energy LLC (Strauss), an affiliate of BayWa r.e. Wind, LLC, show that prior to commencing operations, an Incidental Take Permit (ITP) application for golden eagles is determined complete by the USFWS, rather than an ITP be issued, or intended to be issued, or not needed as required by 16CUP-00000-00031. On August 21, 2023, an appeal of the Planning Commission's action was filed by one party, the Santa Barbara County Coalition of Labor, Agriculture & Business (COLAB) (Case No. 23APL-00034).
