#### **Recommended Actions:**

That the Board of Directors of the Redevelopment Agency:

A. Approve and authorize the Chairman to execute the Voluntary Merger for parcels 075-111-006 and 075-111-014, as required for the issuance of the Coastal Development Permit, 08CDP-00000-00076, for the Isla Vista Redevelopment Agency Parking Lot [Attachment 1].

## **Summary Text:**

This item is on the agenda to consider a Voluntary Merger prepared by the Santa Barbara County Surveyor's Office for parcels 075-111-006 and 075-111-014, located at 881 Embarcadero Del Mar in Isla Vista. The Merger is a requirement of the Conditions of Approval for the Coastal Development Permit for the Isla Vista Redevelopment Agency Parking Lot, approved by the Planning Commission on December 03, 2008. Since the parking lot will be constructed over two adjacent parcels, they must be merged.

#### **Background:**

Located at 881 Embarcadero Del Mar, the forty five space public parking lot will be centrally located in downtown Isla Vista and will serve local businesses and residents. The parking lot design includes landscaping and shade structures as well as a pocket park with a natural seating area in the southeast corner of the property. The Board authorized the acquisition of the property at 881 Embarcadero Del Mar in Isla Vista from Union Oil Corporation of California on June 3, 2008.

On June 13, 2008, the Board of Supervisors made findings required by Health and Safety Code Section 33445 for the Redevelopment Agency funding of infrastructure and physical improvement projects.

A CEQA Addendum to the Isla Vista Master Plan EIR (2007), 03-EIR-08, was filed with the Clerk of the Board on December 3, 2008 for the Isla Vista Parking Lot Project.
