Recommended Actions:

That the Board of Supervisors:

- A. Approve and authorize the Chair to execute a Contractor on Payroll Agreement with **Daniel Litten, M.D.**, for the provision of medical support services for the period of July 1, 2022 to June 30, 2023 in an amount not to exceed **\$15,000.00** (Attachment A);
- B. Approve and authorize the Chair to execute a Contractor on Payroll Agreement with **Edwin Feliciano, M.D.**, to provide psychiatric services for the period of July 1, 2022 to June 30, 2023 in an amount not to exceed **\$26,400.00** (Attachment B);
- C. Determine that the above actions are government fiscal activities, which do not involve any commitment to any specific project that may result in a potentially significant physical impact on the environment and are therefore not a project under the California Environmental Quality Act (CEQA) pursuant to section 15378(b)(4) of the CEQA Guidelines.

Summary Text:

The Department of Behavioral Wellness (BWell) provides specialty mental health services to adults with mental illness and children with serious emotional disturbances, in part through contracted providers, including Contractors on Payroll (COP). The above-referenced contracts comply with the Santa Barbara County Contractor on Payroll Policy, approved by the Board of Supervisors on October 20, 2015. Approval of the above-referenced contracts will ensure the continued provision of critical mental health and related services during FY 22-23.

Background:

BWell has experienced continued difficulty recruiting and retaining psychiatrists and other individuals who are certified and licensed to provide specialty and ancillary mental health services to the area. Although the County maintains ongoing recruitment for psychiatrists, psychiatric nurses, and individuals certified and licensed to provide ancillary mental health services, it rarely produces enough qualified candidates to meet departmental needs. A COP helps to bridge the gap in mental health treatment capacity.

Edwin Feliciano, M.D. provides psychiatric services and support to both the Psychiatric Health Facility and the Crisis Stabilization Unit during the weekend and holiday hours when it is most challenging to staff these facilities.

Daniel Litten, M.D. provides medical support services for mandated on-call and independent evaluations at the Crisis Stabilization Unit (CSU), during use of seclusion and restraints at the Psychiatric Health Facility (PHF), and 5250 certification evaluations at the PHF. Support services include being on-call Monday through Friday, 10:00 PM to 7:00 AM, and for twenty-four (24) hours on Saturday and Sunday, including holidays. In addition, Dr. Litten works with PHF and CSU staff to provide: patient diagnosis; behavior requiring seclusion/restraint or both; medical prescriptions; patient interviews, and notations on the designated seclusion/restraint form. Dr. Litten also provides: on-call and as scheduled internal medicine duties, which include the provision of complete medical histories and physicals for PHF inpatients and CSU outpatients within twenty-four (24) hours and follow-up medical care.

Dr. Feliciano has continually met his contractual obligations to provide psychiatric services to BWell clients at the BWell Psychiatric Health Facility and Crisis Stabilization Unit. Dr. Feliciano has successfully provided these services while adhering to all workplace requirements, such as State and local health officer orders.

Dr. Litten has continually met his contract requirements to provide medical support services to BWell clients as needed by BWell clinical staff. Dr. Litten's on-call services are essential during a time of employment shortages.
