### **RE: REQUEST \$18,000 FROM SOUTH COAST WEST QUIMBY TRUST FUND #1400 TO OFFSET THE COST OF THE ANISQ'OYO' BRIDGE REHABILITATION PROJECT**

Dear Mr. Hernandez:

There are three bridges in the District's downtown park, Anisq'Oyo' Park, and all are in a state of disrepair. The Isla Vista Recreation and Park District is in the process of submitting the administrative paperwork to use a portion of our Prop 40 funds to finance the bridge repair project. However, we will be short \$18,000 according to our cost estimate for the project.

Since the spring of '08 the eastern bridge has been closed off to public access awaiting repair. Our main bridge that facilitates very heavy ingress and egress will suffer the same fate if not addressed soon. The third bridge over the pedestrian sidewalk also needs attention. The cost of rehabilitating the three bridges has been estimated at \$180,000.

On December 4, 2008 the Board of Directors reviewed the plan to use Prop 40 State Grant Block Grant funds to finance the majority of the repair. However, we are in need of an additional \$18,000, and seek support of the South Coast West Quimby Trust Fund.
