Title: Accept the California Department of Justice Tobacco Grant funds

Budget Action: Increase appropriations of \$75,000 in Sheriff General Fund for Salaries and Benefits funded by unanticipated revenue from Intergovernmental Revenue-State.

Justification: The people of the State of California have enacted The California Healthcare, Research and Prevention Tax Act of 2016 (Proposition 56), which provides local public agencies with funding to promote a healthier California by reducing illegal sales and marketing of cigarettes and tobacco products to minors. The Office of the Attorney General makes these annual funds available to local law enforcement agencies through the California Department of Justice Tobacco Grant Program

On 10/2/2019, the Sheriff's Office received notification that our grant application was approved by the State of California Department of Justice and would be awarded \$553,029.00 over a 3-year grant cycle, for use of increasing law enforcement staffing to reduce illegal sales, marketing of cigarettes and tobacco products to minors. The grant proposal included funding for a School Resource Deputy in the Santa Ynez Valley that would also be available to assist with enforcing tobacco laws in other areas and educational programs. Additional funding was requested and approved for deputies to assist the Public Health Department with tobacco sting/decoy operations to reduce sales of tobacco products to minors.
