IRREVOCABLE OFFER OF DEDICATION OF EASEMENT

ORCUTT RANCHO, LLC, a Colorado Limited Liability Company, as the owner of a twenty foot wide sewer line easement recorded on August 17, 1977 as Instrument No. 77-41450 of Official Records of Santa Barbara County, California, and more particularly described in Exhibit "A" attached hereto and incorporated by this reference, referred to as GRANTOR herein:

FOR A VALUABLE CONSIDERATION DOES HEREBY IRREVOCABLY OFFER FOR DEDICATION TO LAGUNA COUNTY SANITATION DISTRICT, a county sanitation district of the State of California, as GRANTEE herein, the aforementioned twenty foot wide sewer line easement, including all rights to use said easement for present and future construction, reconstruction, operation, repair, and maintenance of improvements required by GRANTEE for GRANTEE's operations related to sewer line improvements, in such number and size, and with such accessory parts and structures, and with all surface and subsurface appurtenances incidental thereto, as GRANTEE, or its successors in interest, may from time to time deem necessary to install within the easement, together with necessary rights of ingress and egress to the easement for the above-referenced purposes, in, on, along, under and through that certain land situated in the County of Santa Barbara, State of California, more particularly described in Exhibit "A" attached hereto and incorporated by this reference.

This Offer of Dedication of Easement is made pursuant to the procedures set forth in California Government Code Section 7050 and, when recorded, shall become irrevocable and binding on GRANTOR, its successor and assigns, and may be accepted at any time by the Board of Supervisors of the County of Santa Barbara, acting as the Board of Directors of GRANTEE.



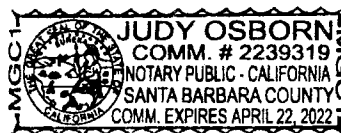

EXHIBIT "A"

TWENTY FOOT WIDE SEWER LINE EASEMENT

Being a portion of the subdivisions of Lots 11 and 12 of the division of Rancho Punta de la Laguna, County of Santa Barbara, State of California, more particularly described as follows:

Beginning at a point on the northerly line of State Highway No. 1 as shown on a map filed in Book 46, Page 13 of Record of Surveys, from which a 1" iron pipe with brass cap marked R.E. 7487 as shown on said filed map bears North 69° 55' 03" West, 1527.18 feet; thence along the centerline of a twenty foot sewer line easement North 20° 04' 57" East, 2711.11 feet to a point in the northerly line of that land shown on above mentioned Record of Survey, from said point a 3/4" iron pipe tagged R.E. 2928 bears South 87° 48' 40" East, 247.88 feet.

Note: The sidelines of the above described twenty foot wide sewer line easement shall be lengthened or shortened to form a closed figure.
