- a) Approve and authorize the Chair of the Board of Supervisors to execute an agreement with the California Department of Food and Agriculture (CDFA) for the Weighmaster Compliance Program of Santa Barbara County for the period of July 1, 2022 through June 30, 2023 in the amount of \$1,200.00.
- b) Determine that the above action involves government funding mechanisms and/or fiscal activities and is not a project under the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines section 15378(b)(4).

This item is on the agenda for the Board of Supervisors to approve and authorize an agreement with the CDFA to receive reimbursement for the cost of inspecting assigned junk dealer and recycler establishments licensed as weighmasters.
