#### **Recommended Actions:**

a) Accept the Grant Deed for Stonegate Park from Stonegate Orcutt Venture, LLC, and instruct the Clerk of the Board to endorse thereon the Board's acceptance.

## **Summary Text:**

As required by the conditions of development, Stonegate Orcutt Venture, LLC has completed the improvements for the neighborhood park at the Stonegate subdivision in Old Town Orcutt and County Parks has accepted the improvements. The conditions further require that once complete, the park is to be dedicated in fee to the County. This action also completes the requirements for the development of the park and will officially transfer day to day management of the facility to the County. Per the conditions, the developer's maintenance period remains in effect through September 2011.

Background: The approvals of the Stonegate development project required that the developer construct and dedicate to the County an approximately one-half acre neighborhood park at the corner of First Street and Soares Avenue to serve the subdivision and this part of Old Town Orcutt. The park was developed with a small picnic area, children's play area (tot lot) and with a small turf area for passive recreation. The park was deemed complete with all amenities installed per the approved plans in September 2008. The acceptance of the completed improvements began the three year developer provided maintenance period. In April 2009, the developer brought forth the documentation to grant the park to the County at and County Real Estate Services worked with the developer's escrow company to produce clear title for the property that is now being brought forth for your Board's action.

#### **Narrative:**

The conditions of development for the park require the developer to retain maintenance responsibility for the park for a period of three years and that period began in September 2008. County Parks will manage the use of the facility. The Stonegate development is part of the Orcutt CFD and proceeds from the CFD will fund County Park's management and future maintenance efforts.
