## SECOND AMENDMENT TO AGREEMENT FOR SERVICES OF INDEPENDENT CONTRACTOR

THIS AMENDMENT TO AN AGREEMENT is entered into by and between the:

COUNTY OF SANTA BARBARA, CALIFORNIA, hereinafter referred to as "COUNTY", and

THE REGENTS OF THE UNIVERSITY OF CALIFORNIA ON BEHALF OF THE UNIVERSITY OF CALIFORNIA, AT SANTA BARBARA, hereinafter referred to as "UNIVERSITY",

WHEREAS, COUNTY and UNIVERSITY have an existing Agreement dated June 27, 2006 for the operation of the Community Household Hazardous Waste Collection Center at the Environmental Health and Safety Hazardous Waste Facility;

## NOW, THEREFORE, IT IS AGREED as follows:

- 1. The Agreement is amended by replacing Section 4 as follows:
  - 4. **TERM**. UNIVERSITY shall commence performance on July 1, 2006 and end performance on June 30, 2012 unless otherwise directed by COUNTY or unless earlier terminated.
- 2. The Agreement is amended to replace Paragraph A of EXHIBIT B, PAYMENT ARRANGEMENTS as follows:
  - A. For UNIVERSITY services to be rendered under this contract, UNIVERSITY shall be paid a total contract amount, including cost reimbursements, not to exceed \$2,920,673.10.
- 3. The Agreement is amended by attaching Attachment B1 (Schedule of Fees for FY 10/11 FY 11/12).
