Recommendation(s):

That the Board of Supervisors:

- A. Review and approve the Statement of Final Quantities for the project;
- B. Accept the Notice of Completion for the work performed by R. Burke Corporation, 865 Capitolio Way, San Luis Obispo, CA 93401 and direct the Clerk of the Board to record.

Executive Summary and Discussion:

This project consisted of the construction of day use improvements at Rancho Guadalupe Dunes County Park. The improvements consist of a paved parking area to accommodate approximately 50 vehicles, a public restroom, picnic and interpretive facilities. The previous dirt and gravel parking area was removed.

The project was bid in accordance with the Public Contract Code which requires the County to award to the lowest responsible bidder.

County Parks accepted this project as complete on March 25, 2005. The project was completed on time and within budget.
