NOTICE IS HEREBY GIVEN that on Tuesday, June 6, 2023, the Santa Barbara County Board of Supervisors will hold a public hearing to consider the Proposed Fee Ordinances for the Issuance of Permits for, and Related Supervision of, Encroachments and Excavations in County Road Right of Way Public Works Transportation Division, All Supervisorial Districts.

This item is to consider adjusting permit fees to streamline the process and recover costs in conformance with Board policy approved March 14, 2023. Updated fees reflect the impacts of inflation, other cost increases, and changes to service structure. The fees for the Public Works Transportation Division have not been studied or modified since 2007.
