SCA Currently Pays All Utilities and Services Provided

SCA Proposes a Business Case that Request One-Time and Ongoing Funding from the County

SCA Request- One-Time Funding

Requests \$36,320 in Site Improvements
Over Three Years

Site Improvements Include Maintenance Services and Repair of a Block Wall Fence

Funding from County Service Area No.11

SCA Request- Ongoing Funding

Request \$3,120 per Year For Ongoing Operating Costs

Funds to be used for ongoing maintenance, nursery management and utilities

- Require Association to pay for costs
