Recommended Actions:

That the Board of Supervisors:

- a) Approve the specifications for Construction of Ray Road Rehabilitation Project, County Project No. 820714, to repave approximately 2.5 lane miles in the Third Supervisorial District, on file in the Public Works Department office;
- b) Award the attached construction contract in the amount of \$409,430 to the lowest responsible bidder, CalPortland Construction, Inc. (a Local Vendor), 1625 East Donovan Road, Santa Maria, CA 93456, subject to the provision of documents and certifications, as set forth in the specifications applicable to the project, as required under California Law;
- c) Approve and authorize the Chair to execute the attached construction contract, which has been reviewed and approved by County Counsel, Auditor-Controller, and Risk Manager, or their authorized representatives;
- d) Authorize the Public Works Director or designee to approve change orders for a contingency amount up to \$33,471.50 plus an additional amount of \$10,000 for supplemental work items for the Construction on Ray Road Rehabilitation Project in the Third Supervisorial District, for a total not to exceed authorization of \$452,901.50; and
- e) Determine the project was found by your Board to be exempt from the provisions of the California Environmental Quality Act pursuant to 14 CCR 15301(c) on July 25, 2017 (as the proposed project(s) consists of the operation, repair, maintenance, or minor alteration of existing public or

private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of use beyond that previously existing, including but not limited to existing highways and streets, sidewalks, gutters, bicycle and pedestrian trails, and similar facilities), a Notice of Exemption was filed on that basis, and the proposed action is within the scope of the attached Notice of Exemption.

Summary Text:

This item is on the agenda to award a construction contract. On Thursday, February 22, 2018, eight bids were opened for the Construction of Ray Road Rehabilitation Project in the Third Supervisorial District, County Project No. 820714. CalPortland Construction, Inc. submitted the lowest responsible bid in the amount of \$409,430, which is 13.4% below the Engineer’s Estimate. The second lowest bid was 7.5% below the Engineer’s Estimate.

This project was bid in accordance with the Public Contract Code, which requires the award go to the lowest responsible bidder. Public Works analyzed the bids and determined the low bid is responsive and responsible. Public Works recommends awarding this contract to CalPortland Construction, Inc.

Background:

The stretch of Ray Road to be rehabilitated has Pavement Condition Indexes as low as 4, on a scale from 0 (worst) to 100 (best). This project will resurface approximately 2.5 lane miles of County maintained road. The location is included on the attached Project Location Map (Attachment B). Construction is scheduled to begin in May 2018 and completed by July 2018. Traffic control will be provided. Public Works will notify emergency response services and will use construction area signs to notify the traveling public of any significant delays or temporary road closures.

Your Board approved the filing of the California Environmental Quality Act (CEQA) Exemption on July 25, 2017, as part of the Fiscal Year 2017/18 Road Maintenance Annual Plan (RdMAP) approval, in conformance with CEQA Guidelines Section 15301(c). The adopted 2017/18 RdMAP lists all of the streets that will receive a preventive treatment under this contract.

This pavement rehabilitation project is one strategy the Department employs in its Pavement Preservation Program. The first step is to grind, recycle and compact the existing roadway to create a new structural section. The roadway will then be repaved in two layers, one asphalt base and finally an asphalt cap. The road will then receive striping and new pavement marking as a final step.
