SUBJECT: Establish No Parking Zone on Foxenwood Lane in the Fourth Supervisorial District.

**RECOMMENDATIONS:**

That the Board of Supervisors adopt a resolution establishing no parking zones on Foxenwood Lane in the Orcutt area.

**ALIGNMENT WITH BOARD STRATEGIC PLAN:**

The recommendation is primarily aligned with Goal #2: Ensure the public health and safety and provide essential infrastructure.

**EXECUTIVE SUMMARY & DISCUSSION:**

Foxenwood Lane is a two-lane major collector road with bike lanes in the Orcutt area. There have been problems with vehicles parking in the bike lane, especially near Wilson Drive. These parked cars inhibit the sight distance of drivers on Wilson Drive at this intersection. The California Highway Patrol requested no parking signs at this location to alleviate this problem. Based on a field review, the Public Works Traffic Section concurs with the California Highway Patrol, and has prepared the attached resolution to establish a no parking zone at the following location:

- On both sides of Foxenwood Lane between the centerline of Clark Avenue and the City Limits of Santa Maria.
