Recommended Actions:

That the Board of Supervisors:

- a) Approve and authorize the Chair to execute the attached Lease Agreement between the County and New Cingular Wireless PCS, LLC, doing business as AT&T Wireless (collectively "AT&T Wireless"), to allow AT&T Wireless to construct, operate and maintain a telecommunications facility on a portion of the County-owned property known as Vandenberg Hills Little League, located at 300 Albiero Avenue, in Lompoc, also known as Assessor's Parcel Number 097-371-051, for a term of five (5) years, with three (3) options to renew the Lease for five (5) years each, and an annual base rent of Thirty Thousand Dollars (\$30,000.00) (Third District); and
- b) Determine that the proposed action of approving AT&T Wireless' leasing, construction, operation and maintenance of the wireless communication facility is exempt from the California Environmental Quality Act (CEQA) guidelines, pursuant to Section 15303, *New Construction or Conversion of Small Structures*, and Section 15304, *Minor Alterations to Land*, and approve and direct staff to file and post the attached Notice of Exemption on that basis.

Summary Text:

This item is being brought to the Board of Supervisors to request the Board's approval and execution of the Lease Agreement with AT&T Wireless at Vandenberg Hills Little League ("Lease") to allow AT&T Wireless to construct, operate and maintain a telecommunications facility on a portion of the County-

owned property known as Vandenberg Hills Little League, located at 300 Albiero Avenue, in Lompoc (“Property”). The Lease will be for an initial term of five (5) years, with three (3) options to renew the Lease for five (5) years each, with an annual base rent of Thirty Thousand Dollars (\$30,000.00).

Background:

The Santa Barbara County Planning Commission reviewed AT&T’s proposed project of constructing a cell site facility on July 29, 2020. The proposed wireless telecommunications facility would provide capacity, coverage, and high speed data in the residential area of Lompoc near the Property. The project was approved by the Planning Commission on July 29, 2020 as Case No. 19CUP-00000-00022.

The facility will consist of one 57-foot tall monopole; and a 730 square foot lease area with all supporting equipment contained within an area enclosed by an 8-ft tall CMU Block Wall. The entire telecommunications facility will be located near existing 40-foot storage containers at the rear property line of the parcel away from the ball fields.

This Lease Agreement will allow AT&T to construct and operate this new telecommunications facility for an initial term of five (5) years, commencing as of May 1, 2021, and three (3) additional terms of five (5) years each. The annual base rent will be Thirty Thousand Dollars (\$30,000.00) with an annual cost of living adjustment of three percent (3%). If all renewal terms are extended, the total rent consideration paid during the term of the Lease will be \$806,111.23.

Approval of the Lease allowing AT&T Wireless to construct, operate and maintain a new telecommunications facility on the Property is exempt from environmental review pursuant to Sections 15303, *New Construction or Conversion of Small Structures* and 15304, *Minor Alterations to Land* of the Guidelines for Implementation of the California Environmental Quality Act (CEQA). Section 15303 exempts the construction and location of a limited number of new small facilities or structures. Section 15304 exempts minor alterations in the condition of land, water, and/or vegetation which do not involve the removal of healthy, mature, scenic trees except for forestry and agricultural purposes including grading on slopes of less than ten percent, landscaping, and minor trenching and backfilling where the surface is restored. See the attached Notice of Exemption for a more detailed discussion of the CEQA exemption.
