- c) Adopt the Planning Commission Recommended Draft Toro Canyon Plan dated April 2001, subject to the Board's consideration of additional recommendations from staff and with any additional changes that may be directed by the Board;
- d) Adopt a Resolution and Ordinances amending the Local Coastal Program (Land Use Plan and Article II Zoning Ordinance text and maps);
- e) Adopt Resolutions and Ordinances amending the Land Use Element, Circulation Element, and Article III Zoning Ordinance text and maps;
- f) Adopt appropriate Findings, Statement of Overriding Considerations, and Mitigation Monitoring & Reporting Plan supporting the Board's final action in adopting the Toro Canyon Plan.

COUNTY ADMINISTRATOR'S RECOMMENDATION: POLICY

a) Conducted Public Hearing, received staff presentations and public testimony on all issues except for Water and Wastewater. Water and Wastewater presentations continued to August 27, 2001.

b) through f) Continued to August 27, 2001.

Directed staff to modify language of PRT-TC-1.3 regarding Padaro beach access to include language proposed in Planning and Development Memorandum dated July 25, 2001. In addition, consider the comments of Mr. Steve Amerikaner making the Board of Supervisors the body to determine if there is insufficient opportunity for public beach access.

Clarify PRT-TC-1.4, Santa Claus Lane Beach Access, to address lateral and vertical beach access issues and insert provisions related to the manner in which the opening of any beach access be considered.

Directed staff to reprioritize the list of proposed trails.

Further directed staff to continue to work with the Board of Architectural Review on language of VIS-TC-2.1, 2.3 and 2.9 regarding visual standards and to review findings for exemptions in VIS-TC-2.11.

A motion was made by Supervisor Schwartz, seconded by Supervisor Marshall, that this matter be Continued, as follows: August 27, 2001.
