SUBJECT: Establish a No Parking Zone on El Colegio Road in the Third Supervisorial District.

RECOMMENDATION:

C.A. Recommendation: _____

That the Board of Supervisors adopt a resolution establishing a “No Parking” zone on El Colegio Road in the Isla Vista area.

ALIGNMENT WITH BOARD STRATEGIC PLAN:

The recommendation is primarily aligned with Goal #2: Ensure the public health and safety and provide essential infrastructure.

EXECUTIVE SUMMARY & DISCUSSION:

El Colegio Road is a 32-foot wide arterial roadway that runs between the UCSB campus (Stadium Road) and Storke Road with fronting student housing along the north side, and is located in the Isla Vista Area.

A request was received from citizens in the area to establish a No Parking zone with red curb on the north side of El Colegio Road. Pedestrians using the crosswalk on El Colegio Road have limited sight distance when attempting to cross the road, due to cars that park along the north side of the roadway. The Santa Barbara Traffic Section performed a study at this location and determined that a No Parking zone would create a safer environment for those traveling on El Colegio Road. Therefore, the Public Works Traffic Section has been asked to prepare the attached resolution establishing a No Parking zone at the following location:

- On the north side of El Colegio Road from a point 90 feet east of the centerline of Storke Road to a point 240 feet east of the centerline of Storke Road.
