Recommended Actions:

That the Board of Supervisors approve the Memorandum of Understanding (MOU) between the County of Santa Barbara and the Santa Barbara City School District (District) for school facility use during an emergency or disaster.

Summary Text:

The MOU reflects the procedural, administrative, and functional roles and responsibilities of the Santa Barbara City School District and county agencies during the recent emergencies impacting Santa Barbara County.

During an emergency the department requests various services of the District such as facility use for sheltering. This pre-event agreement establishes a mechanism that allows the County to reimburse the District for those reasonable expenses that the District incurs as a result of assisting the County. The County may then include those incident costs in any requests to the State and/or Federal governments. A pre-event agreement is encouraged by State and Federal officials when reimbursing for appropriate incidents.

Background:

During the past several decades, fire and severe weather incidents have severely impacted county residents, local government agencies, and many school districts. This MOU will be revised and adapted for other school districts in the future. Recent emergencies have impacted the Santa Barbara City School District operations and facilities.

The MOU reflects current operating procedures during a disaster or emergency including a mechanism for reimbursement for District staff or use of District facilities during an emergency. The MOU facilitates reimbursement from Federal Emergency Management Agency (FEMA) or the California Emergency Management Agency (CalEMA) during the recovery phase following an emergency.

Narrative: The budget impacts are undetermined until an emergency occurs. A reimbursement mechanism exists if there is a State proclamation or federal declaration. The County would be responsible for reimbursement to the District if no State proclamation or federal declaration is in effect. This is similar to any other requests made by the County during emergencies from vendors of services.
