That the Board of Supervisors:

Review and approve the Statement of Final Quantities for work performed and materials supplied for this project by the Contractor, R. Burke Corporation (not a local vendor), Post Office Box 957, San Luis Obispo, California 93406-0957, in the amount of \$ 291,562.39.

Alignment with Board Strategic Plan:

The recommendation is primarily aligned with Goal No. 1, An Efficient Government Able to Anticipate and Respond Effectively to the Needs of the Community.

Executive Summary and Discussion:

This project consisted of the reconstruction of Baseline Ave. from the Alamo Pintado Bridge to Lewis Street totaling 750 Lineal Feet. This segment was widened to 34 feet from the original 25 feet to accommodate the Class II Bike Lanes. Drainage Improvements consisted of the installation and construction of seven (7) storm water catch basins and approximately 815 lineal feet of underground conveyance piping.

In addition, the County Maintained Streets of the surrounding area, Cottonwood Street, Lewis Street, and School Road received a conventional asphalt overlay consisting of a leveling course, 3,600 square yards of pavement reinforcing fabric, then a final lift of asphalt concrete for a total of 1.66 lane miles of county maintained roadway resurfaced.
