#### **Recommended Actions:**

That the Board of Supervisors:

- a) Approve the reappointment of the following individuals as regular County Members of the First 5 Santa Barbara County Children and Families Commission, for the term of July 1, 2012 through June 30, 2013.
  - i. Dr. Takashi Wada, County Health Officer representing the Public Health Department;
  - ii. Beverly Taylor, Chief Probation Officer representing the Probation Department; and
  - iii. Kathy Gallagher, Director representing the Department of Social Services
- b) Approve the reappointment of Suzanne Grimmesey, MFT Adult and Children's Division Chief representing the Alcohol, Drug, and Mental Health Department, as an alternate County Member of the First 5 Santa Barbara County Children and Families Commission for the term of July 1, 2012 through June 30, 2013.

### Background:

First 5 Santa Barbara County Children & Families Commission consists of nine regular and four alternate members appointed by the Board of Supervisors. One regular member of the Board of Supervisors and three regular members are "County Members" selected from among the County Health

Officer, the Director of Social Services, the Director of Alcohol, Drug, and Mental Health Services, and the Director of Probation. One permanent position on the Commission is the County Superintendent of Schools, and two members are from the "Community At Large". One Alternate member is a member of the Board of Supervisors, one Alternate is a "County Member" and two Alternates are from the "Community At Large"

The current regular "County Members" are the Director of the Public Health Department, Dr. Takashi Wada, the Director of the Department of Social Services, Kathy Gallagher. Suzanne Grimmesey, MFT, Adult and Children's Division Chief was appointed by the Board of Supervisors to represent the Alcohol, Drug, and Mental Health Services Department. Beverly Taylor, Chief Probation Officer, serves as the Alternate "County Member", and was appointed by the Board of Supervisors in January 2012.

### Performance Measure:

The members of the First 5 Santa Barbara County Children & Families Commission will be required to devote a substantial amount of time attending monthly Commission meetings, and evaluating future funding proposals, monitoring outcomes of existing grants and ongoing Strategic Planning.
