

**AMENDMENT NO. 1 TO AGREEMENT FOR PROFESSIONAL LEGAL SERVICES
(CONTRACT NO. BC- 12-107)**

This Amendment No. 1 hereby amends the Agreement dated February 21, 2012 between the County of Santa Barbara, a political subdivision of the State of California (hereafter COUNTY) and Steckbauer Weinhart Jaffe, LLP (now renamed Steckbauer Weinhart, LLP) (hereafter ATTORNEY).

The Agreement is amended as follows:

1. The name of the contracting party is now updated to Steckbauer Weinhart, LLP. This update applies to the introductory paragraph of the Agreement, Section 2, Notices, and the first sentence of Page 7 of the Agreement.
2. Section 4 is hereby amended to read as follows: **TERM.** ATTORNEY shall commence performance on February 21, 2012 and end performance upon completion, but no later than July 8, 2014 unless otherwise directed by COUNTY or unless earlier terminated.
3. Exhibit B, Section A is hereby amended to read as follows: "For ATTORNEY services to be rendered under this Agreement, ATTORNEY shall be paid a total contract amount, including cost reimbursements, not to exceed \$50,000.00.
4. In Attachment B-1, the sentence "Amounts charged to this Agreement shall not exceed \$25,000." is hereby amended to read as follows: "Amounts charged to this Agreement shall not exceed \$50,000."
5. This Amendment No. 1 may be executed in any number of counterparts and each of such counterparts shall for all purposes be deemed to be an original; and all such counterparts, or as many of them as the parties shall preserve undestroyed, shall together constitute one and the same instrument.

All other terms remain in full force and effect.




