

AMENDMENT No. 2

MEMORANDUM OF UNDERSTANDING

and the  
COUNTY OF SANTA BARBARA  
for  
COASTAL ACCESS PROJECTS ASSOCIATED WITH HIGHWAY 101

This Amendment No. 2 to the Memorandum of Understanding (MOU) executed on June 4<sup>th</sup>, 2019 between the Santa Barbara County Association of Governments (hereafter “SBCAG), and the County of Santa Barbara (hereafter “COUNTY”), is hereby amended (“AMENDMENT NO. 2”) as follows:

1. Modify Recitals to add the following:

WHEREAS, the funding provided for PROJECTS is comprised of LPP FUNDING and SCC FUNDING, hereby collectively referred to as SB1 FUNDING, and regional 101 funding from the Regional Surface Transportation Program herein referred to as REGIONAL FUNDING.

2. Section 4, “Term” is deleted and replaced in its entirety as follows:

The term of this MOU shall commence as of date of execution and shall extend through December 31, 2024, unless otherwise modified and earlier terminated.

3. Section 6, “Funding and Invoicing” subsection “a” is deleted and replaced in its entirety as follows:

SBCAG will allocate the SB1 FUNDING for PROJECTS. *SBCAG will also approve the REGIONAL FUNDING.* Allocation of SB1 FUNDING for particular phases can only occur when necessary progress has been made by COUNTY on prior phases.

4. Section 6, “Funding and Invoicing” subsection “h” is deleted and replaced in its entirety as follows:

SBCAG will make SB1 FUNDING *and REGIONAL FUNDING* available for PROJECTS to COUNTY as shown in Attachment 4 “Funding Split” for PROJECTS. Funding shall be provided to COUNTY by SBCAG on a reimbursement basis.

5. Section 9, “Designated Representative & Notices” is deleted and replaced in its entirety as follows:

PARTIES shall establish a Designated Representative for administering the work to be completed under this MOU for the PROJECTS. Any notice or consent required or permitted to be given under this MOU shall be given to the respective parties in writing, by personal delivery, or with postage prepaid by first class mail, registered or certified mail, or express courier service, to the Designated Representative. Those representatives are shown below:

SBCAG or COUNTY may modify its Designated Representative by providing in writing the new individual's contact name and information to the other PARTY'S Designated Representative. The PARTIES may also provide notice at such other address or to such other person that the PARTIES may from time to time designate in accordance with this Notices section. If sent by first class mail, notices and consents under this section shall be deemed to be received five (5) days following their deposit in the U.S. mail. This Notices section shall not be construed as meaning that either PARTY agrees to service of process except as required by applicable law.

8. **Ratifications.** The terms and provisions set forth in this Amendment No. 2 shall modify and supersede all inconsistent terms and provisions set forth in the Agreement and Amendment No. 1. The terms

and provisions of the Agreement and Amendment No.1 except as expressly modified and superseded by this Amendment No. 2, are ratified and confirmed and shall continue in full force and effect, and shall continue to be legal, valid, binding and enforceable obligations of the parties.

IN WITNESS THEREOF, the parties have executed this AMENDMENT NO. 2 to be effective on the date when fully executed by both parties.
