Recommended Actions:

That the Board of Supervisors:

- a) Receive and file the annual report regarding the Agreement for Medical Services with Wellpath and delivery of clinical treatment by Department of Behavioral Wellness (DBW) for youth detained in juvenile detention facilities; and
- b) Determine that the recommended action is not subject to the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines Section 15378 (b) (5), since the recommended action is a government administrative activity which does not involve commitment to any specific project which may result in potentially significant physical impact on the environment.

Summary Text:

The Probation Department operates two juvenile detention facilities, the Susan J. Gionfriddo Juvenile Justice Center (JJC) and Los Prietos Boys Camp (LPBC). Wellpath has contracted to provide medical services, and coordinate off-site medical treatment and

dental services as required. Behavior health clinical services are provided by the DBW. Pursuant to agreement, Wellpath and DBW are to present a detailed annual report to the Board of Supervisors containing a comprehensive review of the monthly statistical and program reports and examination of significant trends and issues.

Background:

Youth in custody continue to have timely access to quality medical care, and are able to request medical care via call slips collected and triaged by Wellpath nursing staff at least twice a day at both JJC and LPBC. During this past contracted year on-site, nursing staff completed 3,804 clinic visits combined at both facilities. In addition to nursing visits, the pediatrician completed a total of 602 clinic visits. This includes 120 comprehensive Well Child visits, 331 sick visits, and 97 chronic care visits. The most common chronic visits by the pediatrician are related to Asthma, obesity, and hypertension. Psychosocial issues continue to be the biggest health issue facing youth with sexually transmitted infections, substance use disorders, and mental health issues including impacts of childhood trauma. Dental issues are also prevalent, and as mentioned previously are provided by specialists offsite with 67 total dental care visits provided in this past fiscal year.

The DBW has continued to provide clinical treatment to youth in both facilities, including post-custody outreach, engagement support, and linkage services through the Transitions Team. Treatment services utilizing evidence-based principles and best practices include clinical assessment, treatment planning, individual, group and family treatment, crisis intervention, psychiatric evaluation and medication monitoring, case management, and cognitive behavioral treatment intervention delivery (Moral Reconciliation Therapy and Interactive Journaling). Additionally, DBW staff have provided professional training to facility staff in mental health topics such as trauma-informed approaches to managing youth in a custodial setting. During this past fiscal year, DBW provided 105 psychiatric visits, 312 safety checks, 1,500 hours of individual therapy to a total of 1,014 youth, and 59 family sessions totaling 81 hours. The total number of families and youth may be duplicated based on multiple reentries to facilities for the same youth. Recognizing a need for additional family engagement this current fiscal year and challenges presented last year related to the pandemic, and under the leadership of the current assigned supervisor, an increased focus has been placed on earlier contact with family upon admission, enhancement of treatment team processes to emphasize and incorporate family voice, and addressing barriers to family engagement. DBW staff remain available for off hour calls and consultations as needed.

Probation currently meets all Title 15 regulatory standards and is now accredited for the purposes of ensuring exemplary services by the National Commission on Correctional Health Care (NCCHC). This accreditation represents the highest level of care in correctional facilities for youth. Through collaboration with Wellpath and DBW, the Probation Department is able to provide and meet the highest standards involving medical and related care for youth while in a custodial setting.

In collaboration with the Facility Medical Director and the Santa Barbara County Public Health Department's (PHD) Health Officer, Probation continues to maintain comprehensive COVID-19 management and action plans using the Center for Disease Control (CDC) guidelines.

Performance Measure:

PHD conducts quarterly audits of Wellpath’s contract Service Level Agreements (SLAs). A review of the audits for quarters one through four all showed the overall SLA performance objectives 95%, exceeding the 90% minimum standards. There was one area in which the objective did not meet the 90% threshold, in particular vaccines; youth declined/refused vaccination or their parent/guardian declined to consent for vaccination. All other objectives exceeded the 90% minimum standard threshold.

There is no fiscal impact of receiving and filing the report. The Probation Department’s Fiscal Year 2022-23 adopted budget includes funding for the Wellpath contract in the amount of \$1,471,846.16, and funding for DBW in the amount of \$1,062,100.00. The current Wellpath contract expires on March 31, 2023. Approval of the requested action does not change the General Fund Contribution to the Probation Department.
