Recommended Actions:

That the Board of Supervisors to:

- A. Approve plans and specifications for the Pardall Road Enhancement Project in Isla Vista; Third Supervisorial District, County Project No. 720723;
- B. Award the construction contract in the amount of \$2,787,967.00 to the lowest responsible bidder, John Madonna Construction, Inc., 12165 Los Osos Valley Road, San Luis Obispo, CA 93405, (Not a Local Vendor) subject to the provision of documents and certifications, as set forth in the plans and specifications applicable to the project, as required under California Law;
- C. Authorize the chair to execute the construction contract upon return of the Contractor's executed contract documents, and the review and approval of the County Counsel, Auditor-Controller and Risk Manager or their authorized representatives; and
- D. Approve contingency fund in the amount of \$151,898.35 for the Pardall Road Enhancement Project in Isla Vista, County Project No. 720723.
- E. Approve the attached Public Works Budget Revision Request for \$2,939,865.35, allowing the Road Fund to accept reimbursement for this project from the Redevelopment Agency (4/5 vote required).

Summary Text:

On Tuesday, July 8, 2008, seven (7) bids were opened for the Pardall Road Enhancement Project in Isla Vista. John Madonna Construction, Inc. (Not a Local Vendor) submitted the lowest responsible bid in the amount of \$2,787,967.00. The Department has performed an analysis of the bids received. The bids ranged from the low bid of \$2,787,967.00 to the high bid of \$4,195,456.00. The Engineer's Estimate was \$3,169,950.00. The percent

difference between the low bid and the Engineer's Estimate was 12.1%. The percent difference between the low bid and the second lowest bid was 1.7%. John Madonna Construction, Inc. is an established company and has constructed projects for the County in the past.

The Department has determined that the low bid is responsible and reasonable. The Department recommends awarding this contract to John Madonna Construction, Inc. This project was bid in accordance with the Public Contract Code, which requires the award to the lowest responsible bidder.

Background:

The Pardall Road Improvements Project will reconstruct and expand sidewalks, reconstruct the roadway, install street lights, plant street trees, improve pedestrian, bicycle, and motorist accessibility and safety. The project will also improve emergency vehicle access along Pardall Road, improve drainage, upgrade water service, and address ADA accessibility deficiencies. Pardall Road extends from the UCSB Campus to the east to Camino Pescadero in the west. The project is identified in the Isla Vista Master Plan.

Throughout the project's duration, construction area and detour signs will be placed in the appropriate locations on adjacent streets and bicycle, pedestrian and service vehicle access along Pardall Road will be maintained to the maximum extent possible. Because this project involves the reconstruction of a roadway where there are several alternatives for through traffic, inconvenience to the traveling public will be reduced. Public Works and Redevelopment Agency Staff will make all reasonable efforts to minimize the inconvenience and impacts to adjacent property owners and businesses by communicating the schedule of the various construction operations and addressing their concerns whenever possible. A construction hotline, the Redevelopment Agency website, www.ivrda.org, a weekly newsletter on upcoming construction activities, and regularly scheduled construction site tours will help to inform business and property owners. Construction is scheduled to begin in August 2008 and complete in December of the same year.

A Categorical Exemption was filed with the Clerk of the County Board of Supervisors on January 10, 2008, in accordance with County's California Environmental Quality Act (CEQA) guidelines section 15301(c) as adequate environmental review for this project.

On June 13, 2008, the Redevelopment Agency Board of Directors adopted resolution 08-241 and the Board of Supervisors adopted resolution 08-243 making findings required by Health & Safety Code Section 33445 to use Redevelopment Agency funds to construct physical improvements in Isla Vista.
