

**MEDI-CAL PHYSICIAN SERVICES PROVIDER AGREEMENT  
FEDERALLY QUALIFIED HEALTH CENTER**

between

**SANTA BARBARA COUNTY**

and

**CENCAL HEALTH**

**FIRST AMENDMENT**

**Effective February 1, 2012**

**THIS FIRST AMENDMENT** (hereafter referred to as **First Amendment**) to the Medi-Cal Physician Services Provider Agreement, Federally Qualified Health Center is entered into by and between the County of Santa Barbara, an organization approved by the State Department of Health Care Services as a Federally Qualified Health Center (hereinafter referred to as "County"), and the Santa Barbara San Luis Obispo Regional Health Authority, dba CenCal Health, a body corporate and politic, (hereinafter referred to as "CenCal Health").

**WHEREAS**, the Agreement is effective through December 31, 2017; and

**WHEREAS**, In March 2011, the California legislature adopted, and Governor Brown signed into law, Assembly Bill 97 (AB97) which made substantial changes to the Medi-Cal program; and

**WHEREAS**, in October 2011, the Centers for Medicare and Medicaid Services approved the State Plan Amendment implementing certain of these changes, including a ten percent (10%) reduction in capitation to be paid to Medi-Cal managed care plans for Federally Qualified Health Center (FQHC) services as primary care providers; and

**WHEREAS**, in light of these decisions, County has agreed to accept a ten percent (10%) payment reduction in reimbursement from CenCal Health effective February 1, 2012; and

**WHEREAS**, this First Amendment incorporates the terms and conditions set forth in the Agreement approved by the County of Santa Barbara and CenCal Health.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, COUNTY and CONTRACTOR agree as follows:

1. **Definitions.** Capitalized terms used in this First Amendment, to the extent not otherwise defined herein shall have the same meanings as in the Agreement.
2. **Amendments.**
  - a. **EXHIBIT A, ATTACHMENT A-2 PAYMENT ADDENDUM** of the Agreement dated January 1, 2012 shall be replaced in its entirety with **EXHIBIT A, ATTACHMENT A-2 PAYMENT ADDENDUM**, dated February 1, 2012; attached hereto and incorporated herein.

3. **Ratifications.** The terms and provisions set forth in this First Amendment shall modify and supersede all inconsistent terms and provisions set forth in the Agreement. The terms and provisions of the Agreement, as expressly modified and superseded by this First Amendment, are ratified and confirmed and shall continue in full force and effect as legal, valid, binding and enforceable obligations of the parties.
  
4. **Counterparts.** This First Amendment may be executed in several counterparts, all of which taken together shall constitute a single agreement between the parties.
