Appoints Cathleen Fisher, Agricultural Commissioner as agent of the **BOARD OF SUPERVISORS** to conduct all negotiations, execute and submit all documents including, but not limited to applications, agreements, amendments, payment requests, etc., which may be necessary for the completion of the afore mentioned project.
