Box 50085, Watsonville, CA 95077-5085, subject to the provisions of documents and certification as set forth in the plans specifications applicable to the project and as required by law; C. Authorize the Chair to execute the construction contract upon return of the Contractor's executed contract documents and the review and approval of the County Counsel, Auditor-Controller, Risk Manager or their authorized representatives; and Approve a contingency fund in the amount of \$56,502.35 for Construction of 2006/2007 D. Proposition 42 Asphalt Concrete Overlay in the 1st, 2nd and 3rd Supervisorial Districts of Santa Barbara County, County Project Number 810529.

Summary:

On Thursday, January 25th, 2007, three (3) bids were opened for the Construction of 2006/2007 Proposition 42 Asphalt Concrete Overlay in the 1st, 2nd and 3rd Supervisorial Districts of Santa Barbara County, County Project Number 810529. The lowest responsive bid was submitted by Granite Construction Company, (a local vendor, with an office in Santa Barbara), a California Corporation, in the amount of \$880,047.00, which is 24% under the Engineer's Estimate. Public Works staff has performed an analysis of the bid received and has determined that the bid is responsive and reasonable and recommends awarding this contract to Granite Construction Company.

The proposed project is located in the unincorporated areas of Summerland, west of the City of Santa Barbara, west of the City of Goleta and will resurface a total of five (5.0) lane miles of roads. The construction will consist of the repairs of failed pavement areas and placement of a Type B asphalt concrete overlay over a pavement reinforcing fabric and asphalt concrete leveling course. The construction on Modoc road will consist of 0.20' average full width grind to eliminate the excessive crown and re-establish a 2% cross slope, and placement of a Type B asphalt concrete overlay.

This project was bid in accordance with the Public Contract Code, which requires the award go to the lowest responsive bidder.



Background:

The specific project locations were approved by your Board on September 26, 2006 and are a part of the AB 2928 fund, which later became voter approved Proposition 42 signed by the Governor in 2001.
