Recommended Action(s):

That the Board of Supervisors accept and file the Certification of Results for the Consolidated General Election held on November 2, 2010, as required by law.

Summary:

The results of the November 2, 2010 Consolidated General Election was certified on November 30, 2010. Elections Code § 15372 requires the Registrar of Voters to prepare a certified statement of the results of the election and submit it to the governing body within 28 days of the election. An official Certificate of Election Results of the Official Canvass (Attachment A) and an Official Election Summary are attached (Attachment B). The Statement of Votes Cast by precinct for the election is available on the Clerk, Recorder and Assessor & Registrar of Voters website at SBCVOTE.com.

Election Code § 15400 requires that the governing body declare elected to each office voted on at the election the person having the highest number of votes for that office and also declare the results for each measure voted on at the election.

Elections Code § 15620 allows any voter, within five days of the certification date, to file a request for recount with the county elections official of the votes cast for candidates of offices, or any measure provided that the office or measure is not voted on statewide. The request must be filed no later than Monday, December 6, 2010.

Elections Code § 15621 allows any voter within five days beginning the 29th day after a statewide election to file with the Secretary of State a request for a recount of votes cast for candidates for any statewide office or any proposition voted on statewide.
