Re: AB 900 Phase II – Application Requested

Dear Sheriff Brown:

Your county filed an Interest Statement with the Corrections Standards Authority (CSA) by the October 21, 2011 deadline in response to the AB 900 Phase II Request for Applications, Construction or Expansion of County Jails, released by the CSA on October 7, 2011. This letter follows the email that was sent to your county on October 26, 2011, advising that the County is invited to submit an application to CSA by the January 11, 2012 deadline. The application submittal represents the second necessary step in the Request for Applications (RFA) process in order to be considered for Phase II funding.

Following the County's submission of the Phase II application, CSA staff will complete a technical review and provide the County the opportunity to correct technical deficiencies that may be noted by CSA staff. The application will then be forwarded to the AB 900 Phase II Executive Steering Committee for assessment. The Committee's charge is to determine project worthiness in consideration of funding recommendation to the CSA Board. At a future date your county will be contacted regarding a potential interview on February 15 or 16, 2012 with the Executive Steering Committee, an opportunity for the Committee to ask questions about your application.

As you are aware, your county currently holds an AB 900 Phase I conditional award, less than the maximum allowable for Phases I and II combined. The County has options in Phase II with both the relinquishing and admissions preferences, as outlined in the RFA. If the County chooses to relinquish its Phase I award, and seek a Phase II award, the relinquishing and Phase II application must be accomplished by the January 11, 2012 application submittal date. The County can also choose not to participate in the Phase II process. If your county has determined it does not intend to submit an application by the January 11, 2012 due date, we ask that the County please advise CSA staff at its earliest convenience.
