That the Board of Supervisors:

- a) Approve and authorize the Chair to execute the Third Amendment to the Agreement for Service of Independent Contractor with Robert Half Inc. formerly known as Robert Half International Inc. doing business through its division Office Team to provide qualified temporary staff for election-related work, for an amount not to exceed \$750,000 for the period July 1, 2024 through June 30, 2025 (Attachment A); and
- b) Determine pursuant to the California Environmental Quality Act (CEQA) Guidelines Section 15378(b)(5) that the above action is not a project subject to CEQA review because the action consists of organizational and administrative activities of governments that will not result in direct or indirect physical changes in the environment.

Summary Text:

Robert Half Inc. formerly known as Robert Half International Inc. doing business through its division Office Team provides qualified temporary staff to perform critical functions during peak months in the election cycle. Temporary staff assists permanent staff across a variety of election processes including voter registration, poll operations, warehouse logistics, and vote by mail procedures.

Background:

The Clerk-Recorder-Assessor traditionally has the renewal of the aforementioned contract approved via the County Executive Office's ongoing contracts process. However, due to changes pertaining to the FY 2024-25 contract, the agreement was ineligible for renewal through that function.
