Award the construction contract, in the amount of \$676,911.00 to the lowest responsible bidder, Raminha Construction Inc., 6805 Sycamore Road, Atascadero, CA 93422, subject to the provisions of documents and certifications as set forth in the plans and specifications applicable to the project, as required under California Law;
- C. Authorize the chair to execute the construction contract upon return of the contractor's executed contract documents, and the review and approval of the County Counsel, Auditor-Controller and Risk Manager or their authorized representatives; and
- D. Approve contingency fund in the amount of \$46,345.55 for the construction of Cachuma Lake Sewer Lift Station No. 3 Improvements, Project No. D00099.

Summary Text:

This project involves the replacement of the existing sewer lift station no. 3 and the effluent lines at Lake Cachuma County Park. The project also includes the installation of backup generator and automated switches for the lift station.

On March 12, 2009, twelve (12) bids were received and opened for the construction of Cachuma Lake Sewer Lift Station No. 3 Improvements, Project No. D00099. Raminha Construction Inc. submitted the lowest responsible bid in the amount of \$676,911.00. The department has performed an analysis of the bids and has determined that the low bid is reasonable and recommends the award of the contract. This project was bid in accordance with the Public Contract Code, which requires the award to the lowest responsible bidder.

Background:

The relocation of sewer lift stations within the park is required because of impacts from the Bureau of Reclamation's decision to implement a three-foot surcharge of the lake for purposes of providing downstream water during the endangered steelhead fish breeding and spawning cycle. Replacement will preclude accidental spill and lake contamination and provide reliable service into the future.

Fiscal and Facilities Impacts: There are no impacts to facilities with this action. Construction of this project will improve site condition and protection to facilities and equipment from weather damage.

Budgeted: Yes This project is part of the approved Fiscal Year 2007/2012 Capital Improvement Program and can be found on page B-93 'Infrastructure Improvements'.
