

**FIRST AMENDMENT TO CONTRACT FOR  
HIGH ROAD CONSTRUCTION CAREERS: RESILIENT WORKFORCE FUND PROGRAM**

***First Amendment***

This is a *First Amendment* (First Amendment to the Agreement) to the Contract by and between the **County of Santa Barbara** (COUNTY) and **Workforce Development Board of Ventura County**. (CONTRACTOR).

**WHEREAS**, on September 12, 2023, the COUNTY approved the Contract with CONTRACTOR for the provision of High Road Construction Careers: Resilient Workforce Fund Program;

**WHEREAS**, the initial term of the Agreement commenced on October 1, 2023 and is set to expire on March 31, 2026 unless otherwise directed by COUNTY or unless earlier terminated; and

**WHEREAS**, the parties now desire to amend the Contract to increase the total contract amount.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, COUNTY and CONTRACTOR agree as follows.

**The Contract is amended as follows:**

1. Contract Amount in the table on Page 1 of the Contract is amended to \$1,133,665.
2. Section 2, **PAYMENTS**, of the Contract is amended in its entirety:

In consideration of the services rendered in accordance with all applicable terms, conditions and specifications, County will make payment to Contractor in the manner specified in **Exhibit A** and in accordance with the approved budget for this Contract herein included as **Exhibit B-1**.

3. Section 26, **EXHIBIT LIST**, of the Contract is amended in its entirety:

Contractor shall comply with the Contract along with the Exhibits listed below.

Exhibit A-Scope of Work  
Exhibit B-1-Budget  
Exhibit C-General Contract Conditions

4. Section VII.D, **COMPENSATION SCHEDULE**, of Exhibit A is amended to state in its entirety:

In accordance with the approved budget, included herein as **Exhibit B-1**, County shall reimburse to Contractor the approved costs within thirty (30) days of receipt of an approved and accurate invoice. If County finds that an invoice is incorrect or incomplete, County shall notify Contractor of the deficiency within 30 days of receipt of the invoice and Contractor shall make all corrections no later than 60 days upon County's initial receipt of invoice.

5. Replace **EXHIBIT B** with **Exhibit B-1**, as attached.

In all other respects, the Contract remains unchanged and shall remain in full effect.
