**WHEREAS**, property taxes are the largest source of discretionary revenues for the County and are significant revenues for many of the cities, schools and special districts within the county, and

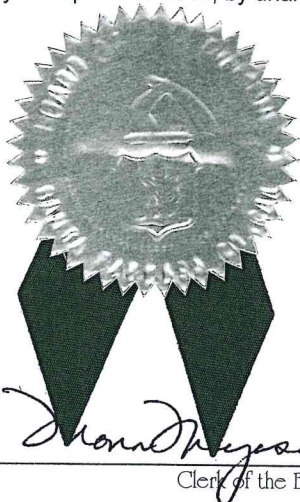
