SUBJECT: Annual Health Inspection of Detention Facilities - 2001

Recommendation(s):

That the Board of Supervisors:

Review and file the attached Summaries of Evaluation from the County Health Officer regarding compliance with environmental, nutritional and medical/mental health requirements for detention facilities.

Alignment with Board Strategic Plan:

The recommendation is primarily aligned with County Goal No. 2: Ensure a safe and healthy community in which to live, work, and visit.

Executive Summary and Discussion:

The County Health Officer is required to investigate the health and sanitary conditions of specified detention facilities in the county on an annual basis. Reports detailing the results of the inspections have been provided to each detention facility manager and to the State Board of Corrections. Report summaries have been provided to the Board of Supervisors, the Sheriff and the Chief Probation Officer.

Mandates and Service Levels:

Section 101045 of the State Health and Safety Code requires annual inspections of adult detention facilities by the County Health Officer and requires copies of inspection reports be submitted to the Board of Supervisors. Section 1313 of the California Code of Regulations, Title 15, require annual inspections of juvenile halls and camps.

Fiscal and Facilities Impacts:

It takes approximately 78 hours of staff time to complete the inspections and monitor remediation efforts. This translates to a cost of approximately \$4,086 which is funded by General Fund local tax dollars. The acceptance of this summary report does not have a fiscal or facilities impact.
