

**RESOLUTION OF THE BOARD OF SUPERVISORS OF THE
COUNTY OF SANTA BARBARA, STATE OF CALIFORNIA**

**IN THE MATTER OF ESTABLISHING TIME)
LIMIT PARKING & PARKING RESTRICTIONS)
IN LOS ALAMOS AND ORCUTT AREA;)
IN THE THIRD AND FOURTH)
SUPERVISORIAL DISTRICT)**

RESOLUTION NO. 21-144

WHEREAS, California Vehicle Code Section 22507 and the Code of Santa Barbara County, California, Section 23-11, authorize the Board of Supervisors of the County, to establish parking regulations on portions of roads and highways under its jurisdiction; and

WHEREAS, it is in the best interest of public safety that certain portions of County highways in Santa Barbara County be designated as no stopping, standing, or parking zones, in accordance with said Sections;

NOW THEREFORE, IT IS HEREBY RESOLVED AND ORDERED, that the following location in Santa Barbara County and under the jurisdiction of the Board of Supervisors of said County are hereby designated as a no stopping, no standing, no parking, or time limited parking zone and that the Director of Public Works of the County of Santa Barbara is hereby authorized and directed to install and maintain appropriate pavement markings and signs at the following location:

No Stopping, Standing, or Parking Zone

- On the east side of Blosser Road from the centerline of Union Valley Parkway to the centerline of Clark Avenue.
- On the west side of Blosser Road from 190 feet north of the centerline of Foxenwood Drive to 161 feet south of the centerline of Foxenwood Drive.
- On the west side of Blosser Road from 190 feet north of the centerline of Rick Road to 128 feet south of the centerline of Rick Road.
- On the west side of Blosser Road from 190 feet north of the centerline of Solomon Road to 146 feet south of the centerline of Solomon Road.

15 Minute Angle Parking Zone (9 AM to 6 PM daily)

- On the west side of Helena Street from 39 feet north of the centerline of Bell Street to 70 feet north of the centerline of Bell Street.

IT IS FURTHER RESOLVED that the Santa Barbara County Director of Public Works or designee is hereby authorized and directed to install appropriate markings and/or signs at said locations as time and resources permit.




