Santa Barbara County Board of Supervisors:

Great Britain, Ireland, Denmark, and several other nations have lifted all or most of their restrictions pertaining to SARS-CoV-2, including face masks, vaccine passports, and mandatory vaccines. Here in America, only nine states continue to impose draconian restrictions. Americans in forty-one states live freely. Meanwhile, UCSB Arts & Lectures requires proof of three vaccinations and recommends wearing two face masks to attend their events. Nick Welsh, who is triple-vaccinated and wears at least one mask, recently got "covid." Instead of having the intellectual honesty to admit that masks and vaccines don't work, he doubled down and called for more restrictions.
