CalMHSA FACT SHEET/TALKING POINTS

April 20, 2012

Background

- CalMHSA is established for the purpose of the Members to jointly develop, and fund mental health services and education programs as determined on a regional, statewide, or other basis
- Authorization operates under a Joint Powers Agreement (JPA) approval by each member's County Board
 of Supervisors and CalMHSA's Bylaws for the operation of the JPA, as approved by the CalMHSA Board of
 Directors
- Present membership is at 90% of the California population, which are 46 members and 46 counties and 1
 JPA. (4 counties have assigned money to CalMHSA and in process of membership, and an additional 5 counties are also in various stages of joining.)
- It is the intent of the Authority that all such programs are fiscally self-contained requiring no additional funds from Members
- Cost to operate Statewide PEI programs are based on funds assigned and plan/budget approval by the Mental Health Services Oversight and Accountability Commission (MHSOAC)
- Yearly budget's adopted by the CalMHSA Board of Directors
- One time member application fee based on county population (\$250 \$1,000)
- Cost to operate other local/regional/statewide programs is based on funds assigned and approved by the CalMHSA Board of Directors
- Subject to the Ralph M. Brown Act, open to public participation
- Membership criteria designed for flexibility with full and limited membership as well as a Memorandum of Understanding

Accomplishments

- Executed contractual agreement with DMH for \$160 million to implement Statewide PEI projects
- JPA is now managing up to 26 different contractors (Program Partners) for the implementation of Statewide PEI projects

• Administers other contracts: A seven county Technical Assistance and Capacity Building Contract thru CiMH and Contra Costa WET Program.

Business Plan/Future Activities

- Investment of funds to ensure a maximum return on funds to be applied to program/services
- JPA has an insurance program with the CSAC Excess Insurance Authority (EIA)
- Affiliate Membership with California State Association of Counties (CSAC)
- JPA is currently collaborating with the California Mental Health Directors Association (CMHDA) on a 5 year business plan and potential role for CalMHSA in the transition of DMH Non-Medi-Cal functions
- CalMHSA and CMHDA Board of Directors collectively provided input on the CMHDA recommendations on the State Administration of Community Mental Health

Why the JPA?

- Acting jointly with members to increase cost efficiency in administration. Rather than individual counties complying with reporting requirements, this task could be centralized, resulting in cost avoidance
- Leverage CalMHSA as a hub to develop multiple requests for proposals and contracts with providers. The JPA facilitates the efficient use of member and provider resources to accomplish the agreed upon goals
- Negotiate cost effective rates with various subcontractors statewide and greatly reduce the cost of overhead administration
- Serve as a repository to house, share and disseminate research, information and specific strategies that are the most effective and quality assured
- Evaluate and analyze potential statewide and regional efforts for systematic results
- Provide members with an alternative to the assignment of county MHSA funds to the state department and state legislature to implement state and regional MHSA projects
