Set hearing on December 12, 2006 (Administrative Agenda) to consider the request of Pat Yochum and Ginger Anderson, agents for the owner, for Case No. 06AGP-00000-00022, for replacement of Agricultural Preserve Contract No. 71-AP-60E.

- A. Accept the request for approval of Agricultural Preserve Replacement Contract 06AGP-00000-00022, and;
- B. Execute the attached Short Form Land Conservation Contract for Assessor's Parcel No. 001-090-010, located on the south side of Casitas Pass Road between Livingston Canyon Road and Gobernador Canyon Road, known as 6405 Casitas Pass Road, Carpinteria, First Supervisorial District.

Summary:

On October 6, 2006, the Agricultural Preserve Advisory Committee voted by a unanimous vote of 5 to 0 (Jensen and Giorgi absent) to find the replacement contract consistent with the Uniform Rules. The effective date for the replacement contract will be January 1, 2007. The subject property has been in an agricultural preserve (71-AP-60C/E) since January 1, 1972, and a replacement contract has been requested due to a change of ownership.

Background:

The subject property has been in an agricultural preserve (71-AP-60C) since January 1, 1972. The original contract, 71-AP-60, was created by the Board of Supervisors by Resolution 72-228 on February 22, 1972 and granted to four owners: McCloskey, et.al. (71-AP-60A), Bliss Lands Inc. (71-AP-60B), Barnard (71-AP-60C), and Phillips Ranch (71-AP-60D). At some point prior to 2006, the naming convention was changed so that 71-AP-60C became 71-AP-60E.

On July 12, 2006, an application was submitted for an agricultural preserve assumption contract for 71-AP-60E due to a change of ownership. On September 8, 2006 the Agricultural Preserve Advisory Committee reviewed the agricultural preserve assumption and recommended that the assumption be withdrawn and the change of ownership be reflected by a replacement contract. Therefore, 71-AP-60E will become 06AGP-00000-00022 under this replacement contract. The request for a replacement contract was carried by a vote of 5 to 0 (Jensen and Giorgi absent) by the Agricultural Preserve Advisory Committee, to find the replacement contract consistent with the Uniform Rules and recommend approval of the replacement contract. The subject parcel is approximately 10.2 acres and is used for avocado orchards.

The Agricultural Preserve Uniform Rules require approval by the Board of Supervisors (BOS); for all replacement contracts. The contract is being replaced due to a change in ownership of the subject

parcel. Uniform Rule #8 prohibits parcels with different titles to be held under one contract.
