### **Recommended Actions:**

That the Board of Supervisors:

- A. Approve plans and specifications for Construction of FY 2012/13 North County Repair Failed Areas in the First, Third, Fourth & Fifth Supervisorial Districts; County Project No. 820637;
- B. Award the construction contract in the amount of \$420,217.00 to the lowest responsible bidder, Granite Construction Company (a Local Vendor), P.O. Box 6744, Santa Barbara, CA. 93160 subject to the provision of documents and certifications, as set forth in the plans and specifications applicable to the project, as required under California Law;
- C. Approve and authorize the Chair to execute the construction contract, upon return of the Contractor's executed contract documents, and the review and approval of the County Counsel, Auditor-Controller and Risk Manager or their authorized representatives;
- D. Approve a contingency fund in the amount of \$33,510.85 for Construction of FY 2012/13 North County Repair Failed Areas in the First, Third, Fourth & Fifth Supervisorial Districts; County Project No. 820637; and
- E. Find that the proposed action is for the repair and maintenance of an existing public facility involving negligible or no expansion of use beyond that which presently exists, that the proposed action is therefore exempt from CEQA pursuant to 14 CCR 15301, and approve the filing of a Notice of Exemption on that basis.

#### **Summary Text:**

On May 9, 2013, four (4) bids were opened for the Construction of FY 2012/13 North County Repair of Failed Areas in the First, Third, Fourth & Fifth Supervisorial Districts; County Project No. 820637. Granite Construction Company, a California Corporation, submitted the lowest responsible bid of \$420,217.00, which is 11% over the Engineer's Estimate.

This project was bid in accordance with the Public Contract Code, which requires the award go to the lowest responsible bidder. The Department analyzed bids and determined the low bidder is responsible. Bids were balanced and the difference between the first and second low bidder was 9.4%. Staff recommends awarding this contract to Granite Construction Company.

#### **Background:**

This project is one of the strategies the Department employs in its annual Preventive Maintenance Program and consists of repairing failed areas and replacement of damaged asphalt concrete pavement. This project includes replacement of approximately 18,700 square yards of asphalt concrete pavement. Your Board approved the filing of the CEQA Exemption on June 12, 2012, as part of the Road Maintenance Annual Plan (RdMAP) approval, in conformance with CEQA Guidelines Section 15301(c).
