

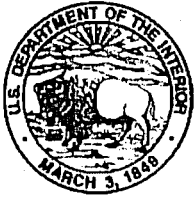

Dear Mr. Beltranena:

This letter constitutes U.S. Fish and Wildlife Service (USFWS) approval of your Grant F12AF700307, Goleta Beach Park Coastal Access and Recreational Enhancement, received in our office February 21, 2012. This Coastal Impact Assistance Grant will be used by the County of Santa Barbara to place a permeable-pier, or other beach-stabilization system in order to provide environmentally sound, long-term protection of the park and sandy beach area. This grant is effective February 21, 2012 through December 31, 2015.

The grant has been approved through Catalog of Federal Domestic Assistance (CFDA) number 15.668, the Coastal Impact Assistance Program (CIAP). This grant is administered through the Wildlife and Sport Fish Restoration Program, CIAP Branch. Details of the award are as follows:

Grant Conditions:

The grantee shall incorporate the following conservation measures to minimize any potential effects on the federally endangered tidewater goby (*Eucyclogobius newberryi*), California least tern (*Sterna antillarum browni*) and the federally endangered western snowy plover (*Charadrius nivosus nivosus*).

- If construction activities will be conducted during the breeding season for western snowy plovers or California least terns (March 1 through September 30), a pre-construction survey of adjacent beach areas should be conducted to ensure that there are no western snowy plovers or California least terns nesting in a location that project activities could directly or indirectly adversely affect the species. If any nests are found, construction should be postponed until nesting activities have concluded.
- Sediment control structures shall be in place to minimize construction runoff into Goleta Slough to prevent degradation of habitat for the tidewater goby.
- If the project will include working in the active wetted channel of Goleta Slough where tidewater gobies could potentially be present. We recommend that the County conduct a survey for gobies using approved protocols, as soon as possible. If tidewater gobies are present the Grantee will contact our office to begin formal consultation.


