On December 16, the Santa Barbara County Board of Supervisors voted to partially terminate the above-referenced Council on Alcoholism and Drug Abuse (CADA) Agreement, for Perinatal Services within the Early Intervention Services, Outpatient Treatment Services, and Intensive Outpatient Treatment Services, effective October 29, 2025, as follows:

The Director or designee will review this data within 60 calendar days of receipt. (See Agreement, Exh. B-ADP, section VIII, part C.)
- Accounting and business records must be retained in accordance with the Agreement. (See, e.g., Agreement, Standard Terms, section 14 (Records, Audit, and Review) and Exhibit A-1, Section 4, Subsection D.)

- Additional instructions concerning the wind-down process may follow this notice.
