- B. Approve and execute the attached Amended Cooperative Agreement between the State of California, City of Santa Barbara, and County of Santa Barbara for traffic signal and roadwork construction at SR 192 and Cieneguitas Road; County Project Number 862262.

Summary Text:

This project includes construction of new signals, sidewalks, and storm drain facilities at the intersection of Cieneguitas Road and Foothill Road (SR 192).

Sealed proposals to construct this project will be received at the Public Works Conference Room, Santa Barbara County, Department of Public Works, County Engineering Building, 123 East Anapamu Street, Santa Barbara, California and at the North County Public Works office, 620 West Foster Road, Santa Maria, California, at a date to be determined, and will be opened publicly and read aloud.
