Recommended Actions:

That the Board of Supervisors:

- a) Approve, authorize, and ratify the Chair to execute a First Amendment to Agreement for Services with the Santa Barbara Unified School District for SERVICES in the amount of \$215,257.25 (SBUSD 2080 hours); and
- b) Approve, authorize, and ratify the Chair to execute a First Amendment to Agreement for Services with the Santa Maria Joint Union High School District for SERVICES in the amount of \$149,025.60 (SMJUHSD 1440 hours); and
- c) Determine that the above actions are government fiscal activities or funding mechanisms which do not involve any commitment to any specific project which may result in a potentially significant impact on the environment, and are therefore not a project under the California Environmental Quality Act (CEQA) pursuant to section 15378(b)(4) of the CEQA guidelines.

Summary Text: The Santa Barbara County Sheriff's Office currently provides School Resource Deputy (SRD) services to both the Santa Barbara Unified School District (San Marcos High School) and the Santa Maria Joint Union High School District (Righetti/Delta High School). This first extension will allow the Santa Barbara County Sheriff's Office and both school districts to extend services from August 1, 2019 through July 31, 2020.

Background:

In August, 2018, the Sheriff's Office entered into a contract with both the Santa Barbara Unified School District and the Santa Maria Joint Union High School District to provide school resource deputy services. This is the first request for an extension that will continue the school resource deputy services through August 31, 2020.

Budgeted:

Fiscal Analysis:

The revenues from the Santa Barbara Unified School District and the Santa Maria Joint Union High School District contract are currently budgeted in the Sheriff's FY2019-20 budget. The cost for the services are included, as the Deputy Sheriff's that will perform the tasks are already hired, trained, and working as the SRD's at San Marcos (Santa Barbara) and Righetti/Delta (Santa Maria) High Schools. These contracts to provide services to schools in the unincorporated areas of the County are designed to recover the full salary and benefits cost of the assigned deputies for the portion of the year contracted. The SRD assignments will conclude on June 30, 2020.
