#### **Recommended Actions:**

That the Board of Supervisors set a hearing for June 24, 2008 to consider the adoption of a revised fee schedule for the Agricultural Commissioner's Office.

#### **Summary Text:**

This resolution updates the fee schedule for the Agricultural Commissioner's Office. The department is proposing an increase in the hourly rate; increase rate charged for export seed inspections; and add a site fee for Certified Producer Certificates. The estimated revenue will increase \$4500 to \$266,864 from the prior fiscal year's fee revenue of \$262,364 representing a 2.0% increase.

#### Background:

This resolution updates the fee schedule for the Agricultural Commissioner's Office. The department is proposing an increase in the hourly rate; an increase in the rate charged for export seed inspections; and add a site fee for Certified Producer Certificates. These three proposed changes are within the range of fees charged by other California counties and are consistent with the Board of Supervisors policy of full cost recovery. All other fees charged by the Agricultural Commissioner's Office to remain the same.

Data supporting the proposed fees has been reviewed by the Auditor Controller's Office and is on file at the Agricultural Commissioner's Office located at 263 Camino del Remedio, Santa Barbara.
