Past Regulatory Issues and Effects on Development

- High salt loading from water purveyor and water softeners
- 1987 requirement to comply with RWQCB Waste Discharge Permit limits for salt content
- 2004 plant upgraded to tertiary treatment and reduce salt
- 1997 Approval of Orcutt Community Plan



Long Range Fiscal Plan - Purpose




- Incorporate Enterprise Fund reserve policy adopted June 2007
- Anticipate rate of growth and new connections
- Worked with CEO and A/C offices on the plan
- Determine sewer service rate impacts

Long Range Fiscal Plan - Details

Sewer service rates proposed to increase 7% next year

5% to 7% increase anticipated for the next 5 years

 Rate of development affects rate schedule



Proposed Sewer Service Charge for 2008-2009

Residential example as collected on tax roll

Proposed annual rate	\$486.38
Last year's rate	\$454.79
Rate increase	\$ 31.59

Equivalent to a monthly increase of \$2.63
