**Recommended Actions:**

That the Board of Supervisors:

- A. Approve plans and specifications for construction of 2010-11 Gallegly SAFETEA-LU Hot Mix Asphalt Overlay in the Third, Fourth, and Fifth Supervisorial Districts; County Project No. 863045;
- B. Award the construction contract in the amount of \$3,111,498.00 to the lowest responsible bidder, Granite Construction Company (a Local Vendor ), subject to the provision of documents and certifications, as set forth in the plans and specifications applicable to the project, as required under California Law;
- C. Approve and authorize the Chair to execute the construction contract, upon return of the Contractor's executed contract documents, and the review and approval of the County Counsel, Auditor-Controller and Risk Manager or their authorized representatives; and
- D. Approve a contingency fund in the amount of \$168,074.90 for construction of 2010-11 and Gallegly SAFETEA-LU Hot Mix Asphalt Overlay in the Third, Fourth, and Fifth Supervisorial Districts; County Project No. 863045.
- E. Find that the proposed action(s) do not constitute a project within the meaning of the California Environmental Quality Act (CEQA), pursuant to 14 CCR 15378 (b) (2); continuing administrative or maintenance activities, such as purchases for supplies, personnel-related actions, general policy and procedure making, which includes award of the construction contract, and approve the filing of a Notice of Exemption on that basis.

**Summary Text:**

On Thursday, December 08, 2011, three (3) bids were opened for construction of 2010-11 Gallegly SAFETEA-LU Hot Mix Asphalt Overlay in the Third, Fourth, and Fifth Supervisorial Districts; County Project No. 863045. Granite Construction Company, Inc., a California Corporation, submitted the lowest responsible bid in the amount of \$3,111,498.00, which is 12.60 % below the Engineer’s Estimate. The Department analyzed bids and determined the low bid is responsive and reasonable. Staff recommends awarding this contract to Granite Construction Company, Inc.

The proposed project is located in the unincorporated areas of Lompoc, Orcutt, and Los Alamos in Santa Barbara County, and will resurface a total of 16.7 lane miles of roadway. Construction will consist of repairing failed pavement areas and placing Type A asphalt concrete over a Stress Absorbing Membrane Interlayer (SAMI), and an asphalt concrete leveling course.

This project was bid in accordance with the Public Contract Code, which requires the award go to the lowest responsible bidder.

**Background:**

On August 10, 2005, the President signed into law the Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU) which authorizes the use of Federal Surface Transportation Programs for highways, highway safety, and transit for a five year period from 2005-2009. This project is the second and final phase of road rehabilitation work utilizing these SAFETEA-LU funds.

The project locations are attached for your information. Your Board approved these project locations as part of the 2011/12 Road Maintenance Annual Plan (RdMAP) on June 7, 2011.
