

FIFTEENTH AMENDMENT TO SOFTWARE SUPPORT AGREEMENT WITH TRITECH SYSTEM

THIS FIFTEENTH AMENDMENT to the System Agreement dated June 27, 2006 with Contractor TriTech Software Systems, a CentralSquare Technologies company, (hereafter "TriTech") is made and entered into this 28rd day of June, by and between the County of Santa Barbara, a political subdivision of the State of California (hereafter "County") and TriTech Software Systems (hereafter "Tritech"), (hereafter the "Fifteenth Amendment"). For purposes of this Fifteenth Amendment, the County and TriTech shall be referred to collectively as the "Parties."

WHEREAS, the Parties entered into an initial agreement to purchase TriTech's CAD system on June 27, 2006 (hereafter the "Agreement"), with an annual Software Support Agreement;

WHEREAS, the Parties renewed the Software Support Agreement with an effective date of April 1, 2023;

WHEREAS, the parties desire to Amend the Agreement to:

- (1) Extend the software support included in the original Agreement for an additional year from April 1, 2023 to March 31, 2024.
- (2) Add a supplemental purchase of additional twenty-two Field Ops licenses to the amount listed in the Fifteenth Amendment for a total of one hundred five license.

NOW, THEREFORE, in consideration of the mutual covenants contained herein, the receipt and sufficiency of which are hereby acknowledged, it is mutually agreed upon as follows:

- (1) The term of the Agreement (Exhibit K), Section 4, Term, is extended from April 1, 2023 to March 31, 2024 for the renewal of Software Support Agreement in the amount of \$207,417.38, for the Software specified in Renewal Order Q-119145, which is due upon execution of this Fifteenth Amendment. For the extended term of April 1, 2023, to March 31, 2024, there will be a supplemental purchase of twenty-two Field Ops licenses for one year will in the amount of \$2,640.00, as specified in Quote # Q-127619, which is due upon execution of this Fifteenth Amendment.

In all other respects, the terms and conditions of the Agreement shall continue unchanged and in full force and effect.

IN WITNESS WHEREOF, the Parties hereto have executed this 15th Amendment to be effective on the date executed by the County.
